

## **Submitting Royal STaC Table Fees**

All Royal STaC payments must be made by credit or debit card, through PayPal, using a link on the New England Bridge Conference (D25) home page website. You do not need a PayPal account. You will no longer have to mail in checks for table fees. This new payment method is easier and more convenient for the club owner and District 25. Your table fees can be paid quickly and easily using the following instructions.

**Please note if you are paying for more than one club you MUST ENTER SEPARATE PAYMENTS FOR EACH CLUB.**

The cost is \$5.25 per table (\$2.62 per half table) for all clubs, except, for the clubs in Unit 126, Connecticut, where the Unit will pay the fees to the district directly, so these clubs will not have to pay anything for participation in the STaC.
