Highlights of ACBL Board Meeting

CEO Report

CEO Jay Baum reported that membership for the first 10 months of 2010 has remained about the same as last year. There will be 11,000 new members for the year, which has been our average for the past several years.

Club table counts are running at about the same level as in 2010 while online tables are expected to increase about 10% to in excess of 600,000 tables. Regional and Sectional tables are about the same as in 2009 and STACs continue to grow; 2010 tables for STACs are expected to set a new record.

Financial Results

For calendar year 2010, Management and the Finance Committee are currently projecting a loss of \$67,000; this result compares quite favorably with the budgeted loss of \$374,000. Unfortunately, the poor table count in Orlando will probably result in a worse result than the current projection of a \$67,000 loss.

For 2011, our preliminary budget anticipates a net income of approximately \$140,000. The final 2011 budget will be prepared in February and approved by the BOD in March. The only fee increase will be Tournament Director fees, which will increase 4% due to salary increases and increased benefit costs for our TDs. I believe this is a very positive result.

Election of ACBL President

Congratulations to Craig Robinson from District 4, who was elected 2011 President. I have every confidence that Craig will be an outstanding President.

Slow Play Regulations

The Board passed new slow play regulations which we expect will provide our TDs with the authority necessary to reduce slow play. As everyone should be aware, slow play, especially habitual slow play, is a violation of law and is subject to penalty. One of my stated goals coming into 2010 was to decrease slow play. As I visited various sites around the country, I found that most of our players enthusiastically support this goal. The TDs who helped draft the new regulations believe the regulations provide them with the authority to enforce slow play penalties. The BOD has stressed to Management the importance of having our TDs uniformly enforce the slow play rules. How well the TDs do remains to be seen.

<u>Top Platinum Masterpoint Winner – 2010 NABCs</u>

Congratulations to Jay Borker, who won the Blue Ribbon Pairs in Orlando and also won 252 platinum masterpoints in 2010, more than any other District 25 player. Rich DeMartino was second with 220 platinum points followed closely by John Stiefel with 216 platinum points. Platinum points are awarded for NABC+ events which are nationally-rated events with no upper masterpoint limit.

I am optimistic that we will continue to make significant advances in technology over the next few years. Thanks to all of you who have helped us achieve our goals. In my view, the honor I have received is a tribute to the District as well. I hope to continue to serve District 25 to the best of my ability.

The 2011 Spring NABC will be held from March 10 through March 20 at the Galt House Hotel in Louisville, Kentucky, home of the Kentucky Derby. The Galt House overlooks the Ohio River and is just a few short blocks from town and attractions such as the Louisville Slugger Museum and the Mohammad Ali Center. The local District Director, Beth Reid, assures me all will have a great time. I hope to see you there.
