Board Meeting Highlights:

The board voted to vacate the titles of part NABC+ winners that have been convicted of cheating.

The original 2 motions were to either vacate the titles and move up just the pair winners, and the other once was to vacate titles and move up all second place to be NABC+ Champions. The committees and full board toiled with this at length and came to a compromise that we could pass as neither motion was gaining any traction as is.

Many felt as I did that its hard to say the second place team is deserving of the title, the cheaters skewed the previous results for example, if I play 2 flat board against a convicted pair and we get 50% and end second and you play 2 swing boards against them that they are able to capitalize on and get near 0 MP in those two boards, then you may well have been second and deserve the win, same in teams the pairings would all be different also. It just becomes a mess when trying to restore equity fairly. We all have great empathy for the second place teams and pairs also and when it seemed we were unable to reach agreement and no titles would be taken at all we altered to what we could all agree on and passed the motion as amended! I feel this was the full board at its best.

192-18: Club Incentive

Moved that: Section D of the Masterpoint Book dealing with Club Awards under the heading

SPECIAL AWARDS IN CLUB EVENTS be modified as follows:

Club Appreciation Team Games – Awards 25% Gold masterpoints for overall positions and match

awards, up to a maximum of 1 masterpoint; remaining awards are black.

Upgraded Club Championships - Awards 25% Gold for overall positions, not session awards or

match awards, up to a maximum of 1 masterpoint; remaining awards are black. Effective January 1, 2020 or as soon as can be implemented by management Carried unanimously

192-25A NABC events designated as "Super Senior" be changed from a minimum of 70 years of age to 75

years of age.

Effective January 1, 2020

Carried unanimously

192-25B Was important to District 25. The motion to slowly change the age to 65 from 60 (Which I have to agree is correct) was being modified to change it all at once to 65 as it was for the super seniors. If this passed it would have dire consequences for our senior regional which is already our weakest regional on the schedule. I was able to bring up this issue (we have signed contracts and would lose money) and convince them back to a slow change that basically allows anyone that has been playing to continue as the age will go to 62 in 2020 and increase 1 year every year until it is at 65.

Full Motion: The definition of a "Senior" for the purposes of participation in all ACBL events 'Senior' be changed from a minimum of 60 years of age to 65 years of age. The requirements earning a "Silver Ribbon" qualification will follow the new Senior Age changes. The following is transition for the senior age change:

Beginning January 1, 2020 Senior Age will be 62 Beginning January 1, 2021 Senior Age will be 63 Beginning January 1, 2022 Senior Age will be 64 Beginning January 1, 2023 Senior Age will be 65 Effective January 1, 2020 192-37 Temporary Memberships have been changed to "Guest Memberships" and are Free. This motion passed without my vote and while it is a good idea, the complete process is not well defined and was presented as a "work in motion". I am not in favor of not defined changes when things that are important like the recruiter bonuses (who gets the money?) was left out and left undefined, this has the potential to upset some of our best recruiters and I feel we have the responsibility to advance a complete plan before voting it in.

Codification Chapter I – Membership, A. Membership Section, 2 – Definitions and Rights of ACBL

Membership be amended to add guest member definition:

- 2.2 Classes of Membership
- 2.2.8 Guest member:
- 2.2.8.1 May join ACBL at no cost;
- 2.2.8.2 Former members may renew as a guest member, granted that they never achieved the ACBL masterpoint rank of Junior Master;
- 2.2.8.3 Membership renewal is required every 12 months;
- 2.2.8.4 The guest membership benefits shall be defined by management policy.

Benefits may be adjusted according to recruitment and upgrading rates;

- 2.2.8.5 The following benefits shall not be available to guest members:
- a. A subscription to the printed version of the Bridge Bulletin
- b. Promotion to the rank of Junior Master or higher
- c. Credit of masterpoints other than black or unpigmented

Governance

After months of planning and trying to come up with a solution to stream line the board to 9, governance came to the meeting and said they have a new great idea that will require a by law change to allow an executive committee to function at any time (rather than just during the period that the board does not meet) so in reality they would replace the 25 voters with 9 of the directors chosen to the EC. There was no plan on how they would be selected, there was no number of directors that would be on the EC, just the proposal said "Lets change the By Laws to accommodate any change that we want to make."

While I have not been convinced that 9 are more likely to make better decisions than 25, I am certain that 9 can make decisions faster than 25. What I feel the ACBL needs is better thought out decisions and better planning and I have a hard time seeing that come to fruition with this plan. Most quick decisions have impact that we did not expect, and a By Law change to the way the governing body works deserves more than "This is what we thought of literally last night" quotes as this is exactly what we were told.

I voted against this change and the motion failed by 1 vote. While the Status Quo is far from perfect it is well thought out and a representative form of governance that I respect. A no holds barred wholesale change without guidelines is less than the ACBL deserves in my opinion. Quick decisions that result in fires being put out later is one of the reasons people are considering the current structure ineffective.

Again my vote just can not go to half planned motions:

Article VII Committees – Section 7.2 Executive Committee of the ACBL Bylaws are hereby deleted in their entirety and replaced with the following:

- 7.2 Executive Committee
- 7.2.1 An Executive Committee of the Board is established, which shall be a committee of the Board. The function of the Executive Committee is to act on behalf of the Board of Directors as meetings provided by Board resolution to the extent allowable permitted by law.
- 7.2.2 The Executive Committee shall be composed of: The number of and method of selecting members of the Executive Committee shall be determined by the full Board.
- 7.2.2.1 The President of the ACBL, who shall chair the Committee. 14
- 7.2.2.2 The Chair of the Board of Directors.
- 7.2.2.3 Three at-large members of the Board, whose appointment shall be made by a majority of the entire board.
